



Background Information

Purnea semen station (PSS) is a unit of Bihar Livestock Development Agency (BLDA), registered under the Society Act in July 2005 for implementation cattle and buffalo breeding in Bihar by strengthening AI network, frozen semen production, delivery of field artificial insemination services including supply of liquid nitrogen, establish and operate semen bank/depot.

Purnea semen station located at Maranga, NH- 31, Purnea – 854303, has an annual production capacity of 5 Million doses. It was established in 2020 under the Rastriya Gokul Mission, DAHD, Gol. During 2020-25, the semen station produced 111.19 lakh FSD. It is projected to produce 52 lakh semen doses in 2025-26 from HGM Bulls received through BDC/DAHD.

Purnea Semen Station is ISO 9001:2015 certified state-of-the-art semen station and has been graded "A" by CMU, Gol.
